It elected to retain funds in the foundation as a means of growing the endowment until the endowment reaches a level better able to support ETHS activities.

The amendment was necessary because it had become increasingly difficult to meet the required one-third public support percentage. The board clearly had the authority to make the change as ETHSF's supporting documents already stated its purpose as being to support ETHS.
